"Hilroy- #StartWriting" Contest Official Rules

By participating in the *Hilroy* "#StartWriting" Contest ("Contest"), entrants (and, if eligible minors, their parents or legal guardians) (collectively "Entrant" or "You") agree to be bound by these Official Rules and the decisions of Wattpad Corp. ("Sponsor"), which are final and binding in all matters.

1. HOW TO ENTER: NO PURCHASE OF ANY KIND IS NECESSARY TO ENTER OR WIN.

To participate in the Contest, you must submit your entry through Wattpad.com ("Website") during the period beginning at 9:00 am EST on August 3rd, 2021, through 11:59 pm EST on September 7th, 2021 ("Entry Period"). Visit the *@ImproveYourWriting* profile Wattpad.com/user/ImproveYourWriting and follow the instructions on that profile ("Instructions") on how to submit your story ("Entry"). All Entries must be received by 11:59 p.m. EST on September 7th, 2021 to be eligible. Eligible Entrants may enter as many times as they wish. If you do not already have a Wattpad account, you will be required to create one in order to enter. Creating an account is free. All Website terms and conditions apply. Accounts or Entries generated by script, macro or other automated means will be void. Website's clock will be the official time-keeping device for the Contest.

All Entries must meet the following criteria:

- Entry must be in English, and your own original work. Entrant must have all rights necessary to post and submit his/her Entry. Entry must not infringe on the intellectual property or other rights of any third party. It is each entrant's responsibility to ensure that he/she has all necessary rights to submit the Entry and to grant the Promotion Entities (defined below) the rights described in these Official Rules.
- Entrant must not have won any previous awards in contests sponsored by Sponsor, Promotion Entities, or a Promotion Entity affiliate. - 2. ELIGIBILITY: Open to legal residents of Canada (excluding Quebec), who are at least 13 years of age. Entrants must agree to the terms and conditions of Sponsor's Terms of Service, a copy of which can be found on the Website. - 4. **WINNER NOTIFICATION/REQUIREMENTS**: Five (5) potential winners will be selected by Prize Provider's judging panel on or about September 27th, 2021 Sponsor or an agent of Sponsor will attempt to notify the potential winners by email or direct message on Wattpad within 24 hours of selection. Potential winners will be required to execute and return an affidavit of eligibility, a liability release and, where lawful, a publicity release within one (1) days of date of issuance. If such documents are not returned within the specified time period, winner notification is returned as undeliverable, or a potential winner is not in compliance with these rules, prize will be forfeited and, at Sponsor's discretion, a runner-up may be selected.

Provider shall recognize or credit Sponsor as a partner associated with the creation of the submission. Prize Winner will have no approvals over the final messaging or its content. Prize Provider reserves the right to edit, interpret or otherwise make changes to the Prize Winner's Entry as Provider sees fit, in its sole discretion. All other prize details are at Sponsor's sole discretion. All federal, state, local and other taxes are the sole responsibility of the winner.

Each Entrant represents and warrants that the Entry and materials and information provided do not contain information considered by Entrant or any other third party to be confidential, and that the Entry, Materials, and information provided do not violate any laws or regulations. In the event a submission is selected as a winning Entry, and Entrant's ownership, rights and the originality of the Entry cannot be verified to the satisfaction of Sponsor and/or Hilroy or is in any other way ineligible, Hilroy may select an alternate winner based on the same judging criteria.
